Re: Partial Notice to Proceed with Construction Activities

Dear Mr. Brown:

I grant your March 4, 2015 request for Columbia Gas Transmission, LLC (Columbia) to begin certain construction activities for the East Side Expansion Project. This approval includes all certificated construction activities in uplands associated with Line 1278 Loop in Chester County, Pennsylvania, including previously excluded tract ALT1-PA-CH-035.00. This approval for the Line 1278 Loop *excludes* construction activities in all wetlands, as specified in the table on page 2 of this letter.

I also grant your request to begin limited work at the Easton Compressor Station in Northampton County, Pennsylvania, as described in Columbia's March 9, 2015 filing. The approved activities at the Easton Compressor Station include site preparation activities and the preparation and use of the adjacent construction laydown yard. Columbia is *not authorized* to construct compressors or compressor buildings, including foundations.

In considering your request, we have determined that Columbia's Implementation Plan filed on December 30, 2014, and supplemental filings dated January 28, February 12, and February 18, 2015, provided the information necessary to meet the preconstruction conditions in the Commission's December 18, 2014 *Order Issuing Certificate* (Order) issued in the above-referenced docket, for the approved activities herein. In addition, we have confirmed the receipt of all federal authorizations relevant to the work associated with this approval.
