On December 18, 2014, Columbia Gas Transmission, LLC ("Columbia") received a certificate of public convenience and necessity from the Federal Energy Regulatory Commission ("Commission" or "FERC") authorizing the construction of the East Side Expansion Project ("ESE Project" or "Project"). #### 1.0 INTRODUCTION

On December 18, 2014, Columbia Gas Transmission, LLC ("Columbia") received a certificate of public convenience and necessity from the Federal Energy Regulatory Commission ("Commission" or "FERC") authorizing the construction of the East Side Expansion Project ("ESE Project" or "Project"). The Project includes, among other things, (i) replacing existing compressors with new compressors at Milford and Easton Compressor Stations ("CS"), located in Pike and Northampton Counties, Pennsylvania, respectively, (ii) installing approximately 9.5 miles of new 26-inch pipeline looping Columbia's existing Line 1278 between Eagle CS and Downingtown CS in Chester County, Pennsylvania, (iii) installing approximately 9.6 miles of 20-inch pipeline looping existing Columbia's Line 10345 in Gloucester County, New Jersey, and (iv) installing various measurement, station piping, and appurtenant facilities at existing sites located in Orange County, New York, Bucks and Montgomery Counties, Pennsylvania, and Harford County, Maryland.

#### 2.0 REQUEST FOR NOTICE TO PROCEED – MILFORD COMPRESSOR STATION

At this time, Columbia formally requests a Notice to Proceed ("NTP") for work associated with demolition activities at the Milford Compressor Station in Pike County, Pennsylvania. No additional environmental permits are required for this work, which will be conducted such that no wetlands or streams will be impacted by the demolition activities. Tree clearing and demolition at the Milford Compressor Station is expected to begin as early as next week; therefore, Columbia requests NTP by January 9, 2015. Columbia has received all applicable environmental permits, authorizations, and clearances for the proposed Milford Compressor Station demolition activities, as summarized in Table 5-1 below. In addition, Columbia proposes to begin tree clearing activities along the interconnects to/from the Milford Compressor Station. As Columbia is awaiting its General Permit (GP-11) for activities within the wetland and waterbody located along a portion of the interconnect workspace, it would confine its activities to the upland areas.

Additional workspace was requested to the north of the station in the Implementation Plan, and a variance for the use of this workspace was requested therein. The revised site layout depicting the additional workspace was provided in the Critical Energy Infrastructure Information ("CEII") volume of the Implementation Plan.
